Bidders should be registered with Central Govt. or State Govt. or State Government under takings. The Contractor/Firm who has experience in repairing operating and maintaining of STP and have established organization for taking up such work and who satisfies the qualification criteria of bid document need only apply. Cover-2 superscribed as "Financial Bid" shall contain the price bid as per the tender document. Both the envelopes, Cover-1 & Cover-2 are to be put in a third bigger envelope on which the name & address of the bidder are clearly mentioned.

b) Cover-I shall contain downloaded copies of following "eligibility information".

The bidder must have experience of Repairing, Maintaining and Operating of STP based on any biological process. Certificate to this effect from the Engineer-in-Charge not below the rank of Executive Engineer of a State/ Semi Gov. Deptt./Central Govt. Dept. or Govt. Undertaking, of India is mandatorily required.

The issuance of tender document does not mean the agency has been technically qualified. Hence agencies / bidders are advised to submit all the relevant documents / credentials required in tender for technical qualification along with their bid.

4. Site Visit: -

The representative of the firm/contractor shall inspect the site himself and make himself conversant with the site conditions. He shall submit the undertaking that he has himself inspected the site.

5. Eligibility Criteria: -

- a) Contractor/ firm must have achieved average annual financial turnover (at current price level) from contract receipt of works (in all class of repairing, maintenance and operation of STP works) of Rs. 20,00,000/- (Twenty Lakh only) in last three (03) financial years.
- b) The bidder/contractor/firm should be registered with central Govt. or State Government department or Central/State Government under Taking.
 - The list of works for similar nature executed by the intending contractor/firm along with performance certificate from the authority under which the work executed, indicating gross amount paid was executed must be submitted. The works executed in state/Central Government Departments, PSUs (Public Sector under takings), Autonomous Bodies of Central and State Govt. Shall only be considered.



Cover-1 (Technical Bid) must contain the followings

- Experience in execution of works of similar nature for each of the last Seven years and detail of work in progress (x) or contractually committed with certificate from the concerned officer not below the rank of Executive Engineer or equivalent from government department or public sector under taking a list of clients with their contract detail shall also be provided.
- Original Bank Draft of Rs.5000 as tender fee. (xi)
- (xii) FDR of Rs. 2,00,000/- (Two Lakh only) as EMD.
- (xiii) Complete Tender document with signatures of the bidder on each page.

d) Cover-2 shall contain

- (i) Price Bid Proforma, where contractor will quote his offer. All rates quoted shall be inclusive of the applicable taxes. (in case of revision of rate of taxes the payment will be adjusted accordingly).
- e) The tender of the contractor/firm who fail to fulfill the eligibility information will be summarily rejected.
- Joint venture not allowed and No subletting of works by the contractor/firm is permissible.

Incomplete Submission of the above documents will lead to the rejection of the tender.



6. Bid Opening Details:

- a) The Technical bid shall be opened on 03.09.2025 at 02:30 PM in the office of Director cum Principal, Govt. Hydro Engineering College Bilaspur (H.P.) by the authorized committee. If the office happens to be closed on the date of opening of the bid as specified, the bid will be opened on the next working day at the same time and venue.
- b) The bids for the work shall remain valid for acceptance for a period not less than 120 days after the dead line date for bids submission.
- Other details can be seen in the bidding documents. The officer inviting tender shall not be held liable for any delays due to system failure beyond its control. Even though the system will attempt to notify the bidders of any bid updates, the employers shall not liable for any information not received by the bidders. It is the bidder's responsibility to verify the website for the latest information related to the tender.
- d) The tenders of the contractor/firms who fail to fulfill the eligibility information will be summarily rejected.



INFORMATION AND INSTRUCTIONS FOR TENDERERS:

The details of work to be carried out and its scope are given in the "Notice Inviting Tender" which also indicates a brief description of the project where work is to be executed. The tenderers are advised to study the same carefully before tendering and they shall be deemed to have fully acquainted themselves with the same.

- 1. The Tenderers should note and bear in mind that the GHEC shall bear no responsibility for the lack of acquaintance of the site and other conditions or any information relating thereto, on their part. The consequences of the lack of any knowledge, as aforesaid, on the part of the tenderer shall be at their risk and cost and no charges or claims whatsoever consequent upon the lack of any information, knowledge of understanding shall be entertained or payable by the GHEC.
- The offer should be valid for 120 (One hundred and twenty) days from the last date for submission of tender.
- The tender should be submitted in the prescribed form and the same should be signed properly as laid down hereunder:
 - a) If the tender is submitted by an individual, it shall be signed by the proprietor above his full name and full name of his firm with its current business address.
 - b) If the tender is submitted by a firm in partnership, it shall be signed by all the partners of the firm above their full name and current business addresses, or by a partner holding the power of attorney of the firm by signing the tender in which case a certified copy of the power of attorney shall accompany the tender. A certified copy of the partnership deed and current business address of all the partners of the firm shall accompany the tenders.
 - c) If the tender is submitted by a limited company or a limited Corporation, it shall be signed by a duly authorized person holding the power of attorney for signing the tender in which case a certified copy of the power of attorney shall accompany the tender. Such limited company or corporation may be required to furnish satisfactory evidence of its signature.
 - d) All witnesses and sureties shall be persons of status and their full names, occupation and addresses shall be stated below their signatures. All signatures affixed on each page in the tender will be dated.
 - e) The tender for the works shall not be witnessed by a tenderer or tenderers who himself/themselves has/have tendered or who may and has/have tendered for the same works. Failure to observe this condition shall render the tender of the tenderer tendering as well as of the witnessing the tender liable to rejection.
 - f) The earnest money deposit will be returned to the unsuccessful tenderers within 45 days after finalization of tender. The earnest money of the successful tenderer will be returned after he deposit performance security in the shape of bank guarantee/FDR pledged in favour of The Director cum Principal GHEC Bandla, Bilaspur HP @ 8% of the Total Quoted Value

- g) The rates shall be written both in words and in figures. Corrections, if any, shall be made by crossing out, initialing, dating and rewriting. In case of conflict between the figures and words in the rates, the latter shall prevail.
- h) The Director Cum Principal, GHEC, Bandla shall have the right of rejecting all or any of the tenders and split the work between two or more parties or may reduce the scope of work and also will not be bound to accept the lowest or any other tender and the Director Cum Principal, GHEC decision in this regard shall be final and binding on all tenderers.
- i) Tenders will be opened in the presence of tenderers who may be present at the time of opening of tender.
- j) The tenderers shall not be entitled during the period of validity of their offers, to revoke or withdraw their tenders or vary any terms in regard thereof without the consent of the Director Cum Principal, GHEC in writing. Tenderer shall get his earnest money forfeited for any violation of this clause.
- k) The tenderer will start the work within 15 days from the date of issue of written order to commence the work. The Director Cum Principal, GHEC shall have a right to forfeit the earnest money deposited by the tenderer absolutely without prejudice to other rights and remedies available with GHEC on the violation of this clause.
- The "Notice Inviting Tender" and this "Information and Instructions for Tenderer" shall form part of the Tender Documents.
- m) Any addendum/corrigendum issued before the date of opening of tender will form part of tender documents.
- n) Intending tenderers should visit the site, satisfy themselves regarding the site conditions, location of site, access roads to the site and collect all relevant information required before tendering for the work, tenderer shall be deemed to have full knowledge of the site, specifications and no excuse as regard to want of information or clarification shall be considered after the tender has been received. A certificate in this regards is to be necessarily uploaded in the technical bid.

SCOPE OF WORK

- a) Running, Maintenance & Operation of an existing Sewage Treatment Plant of 250 KLD capacity and its network and distribution network for three years including providing & deploying all required experienced supervisory technical staff and Operators, periodical checking of the plant, oiling greasing, routine maintenance, changing blower filters, providing necessary safety arrangements and consumables, chemicals, chlorination including pumping for supplying treated water to various buildings flushing tanks, for horticulture use, disposal of dried sludge, screening grits etc.
- b) Maintaining and operating the Sewage Treatment Plant for a period of three years including providing all consumables required and deploying all required supervisory and technical Engineering staff.
- c) Arrange sodium hypo-chloride/ any other recommended chemical for disinfection free of cost during the operation of maintenance period in required quantum for which nothing extra shall be payable.
- d) Responsible for replacement of the spare parts required for proper running the Sewage Treatment Plant during the operation and maintenance period.
- e) In case of any breakdown, shall under take the repair work of the STP within 24 hours and put the plant in operational condition.
- f) Dosing of bleaching powder (chlorine) will be as per the requirement for the STP of 250 KLD.
- g) Repairing/ rewinding of any pump/ blower will be done at free of cost, which get damaged during operation of plant.
- h) Dosing of bacterial media of approved make will be done as per requirement and direction of GHEC.
- Day-to-day general maintenance and servicing of various pumps and blowers should be done as per the requirement.
- j) General upkeep and cleaning of the surroundings so as not to have any foul smell in surrounding area.
- k) Dispose of sludge received from the treatment of sewage.
- Clean the sump/tanks from time to time in your scope.



- m) Intending tenderer should visit the site, satisfy themselves regarding the site conditions, location of site, access roads to the site and collect all relevant information required before tendering for the work, tenderer shall be deemed to have full knowledge of the site, specifications and no excuse as regard to want of information or clarification shall be considered after the tender has been received. Initial checking and operation of STP is in the scope of work of bidder, if any maintenance is required in any machinery of plant has to be done by Bidder for smooth running of Plants.
- n) Electricity input to both the plants from the Electrical substation also have to be checked periodically by bidder for avoiding any hindrance in the operation of plants and if any maintenance is required to be done is in the scope of bidder.
- o) A daily log sheet shall be maintained to record the operation and any maintenance activities of the STP. This will serve as a documented record to ensure continuous and efficient functioning of the plants and to track any operational issues or interventions.
- p) The sewerage pipelines should be regularly inspected to check for any choking or blockages. If any issues are found, necessary repairs should be carried out at the earliest to ensure smooth functioning of the system.





